1	<p>APOLOGIES FOR ABSENCE</p> <p>Apologies for absence were received and accepted from CM, GP, GR, DB, and PG.</p>	
2	<p>DECLARATION OF INTEREST</p> <p>There were no new declarations of interest.</p>	
3 & 4	<p>PRESENTATION BY THE STUDENT LEADERSHIP TEAM – INCLUDING WORK ON VALUES & STUDENT LEADERS WORK WITH GOVERNORS TO IDENTIFY PRIORITIES REGARDING VALUES</p> <p>The student leadership team presented to governors on how they gained their roles, and their ideas moving forward.</p> <p>Governors welcomed Amelia, Lucy, Alex, and Miguel. Miguel spoke about marking and rewards including the move towards more inclusive rewards.</p>	

	<p>Amelia talked to governors about values and how we were moving from having 10 values to 5. Governors were asked to spend some time coming up with values. The suggestions were; integrity, value, respect, tolerance, high aspirations, honesty, and not making excuses.</p> <p>The student leadership team came up with responsibility, aspiration, resilience, respect, and integrity. Lucy would also like passion included as a value.</p> <p>Governors questioned whether inclusivity should also be a value. After some discussion it was agreed that responsibility, aspiration, respect and integrity would be 4 of the values and a final fifth value would be decided upon.</p> <p>Definitions of the values were also discussed. The final values and definitions are: Aspiration – wanting to be the best you can be with passion, enthusiasm and commitment Community – working together and supporting each other to ensure we can all do our best Integrity – honestly doing the right thing even if no one ever knows. Respect – accepting and valuing our differences with courtesy and consideration Responsibility – doing the things you are expected to do and accept the consequences or results of your actions</p> <p>Our Vision Statement is:</p> <p>To have uncompromising aspirations for every individual and for the school to be an exceptional, caring and inspirational community</p> <p>Lucy spoke to governors about future student collaboration. There are plans to have buddy systems in place and social times when students are put together.</p> <p>Governors asked what the priority for the student leadership team is to push the school forward. Alex answered well-being, Lucy answered equality with not only top sets getting opportunities, Amelia replied career pathways – ensuring students are aware of what they need to do for their chosen career and Miguel chose reputation. <i>Governors commented that mentoring is very important and a great initiative.</i></p> <p>Governors would like the student leadership team to come back in the second half of the autumn half term</p> <p>Governors thanked the student leadership team for their time and presentation.</p>	JM

7	<p>MATTERS ARISING FROM THE MINUTES</p> <p>TB provided feedback at the Teaching and Learning meeting.</p>	

	<p>JL will get dates from DN to invite governors to house council meetings. The Head boy and girl attended this meeting. JT will check with CM if she has asked regarding the access to Farnborough Fins.</p>	<p>JL JT</p>
8	<p>REVIEW OF COMMITTEE MEMBERSHIP AND CHAIRS FOR 2018-19</p> <p>EL would like to join the Teaching and Learning and Resources committees. SB would also like to join the same committees.</p> <p>JM to email out committees and chairs information.</p>	<p>JM</p>
9	<p>CHAIRS' ACTION</p> <p>There have been no emergency actions since the last meeting.</p>	
10	<p>HEADTEACHER REPORT</p> <p>JL Circulated a comprehensive and lengthy report in advance of the meeting.</p> <p><i>Governors asked about the three year 11 students that JL had asked to be removed from the data.</i> JL noted that one is now at an alternative provision and two left school the week after census. We would like them to be removed from the data - we can upload up to 12 pages of data to support this. Schools are trying to remove outliers from data but are struggling to get evidence.</p> <p><i>Governors asked whether another reminder regarding changes to the school day will go out before the end of term</i> School replied yes, a booklet will be going out with all the changes.</p> <p><i>Governors noted the uprise in the number of students taking citizenship GCSE</i> School told governors that it is now in two option blocks, giving more students the opportunity to take citizenship as an option.</p> <p><i>JT stated as a side note that EL will be the governor responsible for data protection.</i> <i>Governors asked if we were fully staffed.</i> School replied that we are not fully staffed yet in science until January. JL will teach two periods and LB will be able to teach years 7 and 8. We have appointed a second in science and a science technician. <i>Governors asked if there were continued recruitment problems</i> LW noted that we do have great problems but get there in the end. JL commented that we hold our nerve and 'sell' Kings effectively. JL continued with her report, telling governors about the site and the asbestos coming out over the summer holidays. There is a nine month plan in place to replace the windows. We are impressed with Fowlers' work plan.</p> <p><i>Governors asked what precautions are being taken around safeguarding during the building work</i></p>	

	<p>School replied that all workers are DBS checked. There will be Harris fencing around the work and the compound will be in the netball courts. There will be alarm signs on the scaffolding.</p> <p><i>Governors asked if the work is being done in a block during the holidays.</i></p> <p>School answered no, this will be continuous over nine months</p> <p><i>Governors noted that they have a duty of care to ensure that JL does not take on too much.</i></p> <p>JL continued that we applied for money under the Frimley Fuel Allotments Grant and were given £1000 for library books.</p> <p>LB also met the chair of the Wellcome Trust regarding costs for the Gatsby benchmarks.</p> <p><i>Governors noted that under attendance there are a lot of red arrows.</i></p> <p>School replied that one of the issues is children being authorised to be at home by other authorities such as CAMHS. We will start fining in September for unauthorised absences. Lots of students take holidays at the end of term.</p> <p>It was noted that at the year 10 parents evening parents were told if the children were off they needed to catch up with work. Some parents have the attitude that school should do everything to support their child when they are off for two weeks.</p> <p><i>Governors asked if there is a common correlation between attendance levels and performance.</i></p> <p>School responded yes. If their attendance is 90% or lower they are at least one grade lower in every GCSE.</p> <p>Governors thanked JL for such a comprehensive report</p>

There has been a lot of work following the audit to fill the gaps.</p> <p>There is a new version of 'Keeping children safe in education' out on 3rd September. We may need to change the safeguarding policy a little in response to this. We also need to look at the restraint policy.</p>	<p>JT</p>

This would enable school to fulfil Gatsby benchmark number 6 - workplace experience. <i>Governors answered that a letter with an expression of interest in paying £38 to undertake work experience could be sent to year 10.</i></p>
